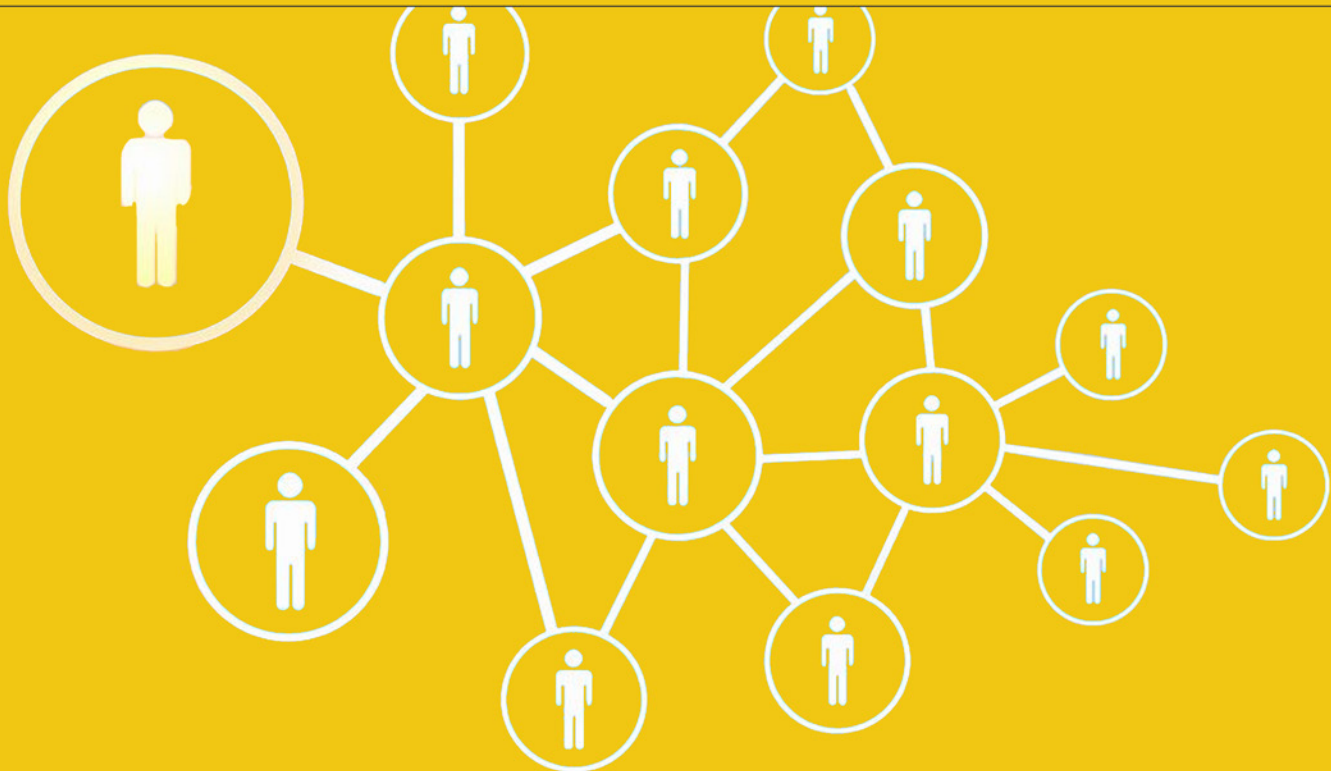

P TO P FUNDING

Peer to Peer Lending is a premier product introduced by Finlender, in its lending boutique.
